ALL DOGS ENTERING THIS PROPERTY MUST BE DOSED FOR SHEEP MEASLES.

PLEASE EMAIL A VALID DOSING CERTIFICATE PRIOR TO THE TRIAL.

1. For all championship events, all dogs must be purebred & registered on the NZKC No. 1 or No. 3 Register.
2. Registration numbers must be supplied with championship entries.
3. Cold game in good condition will be used for each dog.
4. All competitors must be a current financial member of an affiliated club.
5. All competitors / visitors and dogs compete and attend at their own risk.
6. The committee reserves the right to make any alterations to this schedule to meet any unforeseen circumstances.
7. No late or unpaid entries will be accepted.
8. Hazardous obstacles on the ground will be notified to competitors, however competitors must accept that risk may be present in the event of circumstances beyond our control.
9. Each handler is permitted to enter a maximum of 2 dogs per trial. The handler will be allocated draw numbers which allow them to initially run both dogs under one Judge. The second dog must be held on a lead by a steward when not competing. The steward must be organised by the handler.
