Emergency Judges: Club reserves the right to appoint emergency judges for any event.

Conditions of Entry:

- 1. All dogs entered in Championship events must be purebred and registered on the NZKC No. 1 or 3 Register.
- 2. Schedule approved by and trial held under the Rules and Regulations of the NZGTA. These rules will be displayed at the trial.
- 3. All Competitors must be current financial members of an affiliated club.
- 4. All competitors must produce a current 35 day dosing certificate as required by the landowners.
- 5. All competitors and dogs compete at their own risk.
- 6. Game in good condition will be used for each dog in each section of the Championship.
- 7. A monetary penalty of \$10.00 (10 dollars) will be imposed for breach of Regulation Gen. 7. (c).
- 8. The Committee reserves the right to make any alterations to this schedule/trial to meet any emergency.
- 9. No late entries will be accepted.
- 10. Engraving to be the responsibility and cost of the winners
- 11. Walk up retrieve. this event will be for a maximum of 12 dogs, if entries exceed 12 dogs, the club will hold a ballot


