- All dogs entered in Championship events must be pure bred and registered on the NZKC No. 1 or No. 3 Registers.
- Trials to be run under NZGTA Rules and Regulations. These rules to be displayed at the Headquarters.
- All competitors in Championship events must be financial members of an Affiliated Club.
- Game in good condition will be used for each dog in all events.
- There will be a penalty of \$20 charged for contravening NZGTA Regulation Gen. 7(c).
- Any obstacles within the prescribed course will be clearly defined.
- Competitors and dogs compete at their own risk.
- The committee reserves the right to make any changes to this schedule should any unforeseen circumstances arise.
