## CONDITIONS OF ENTRY:

1. All dogs entered in the Championships must be purebred and registered on the NZKC No 1 or 3 Register.
2. This schedule has been approved by, and the trials will be run under the NZGTA Rules & Regulations. Rules to be displayed at the Championship.
3. All competitors must be members of an affiliated Club.
4. No late entries will be accepted.
5. Game in good condition will be used for each dog in each section of the Championship.
6. There will be a penalty of \$5 for any dog that is in breach of Regulation Gen.7. (c).
7. All competitors and dogs compete at their own risk.
8. The Committee reserves the right to make any alterations to this schedule to meet any emergency.
9. A current dosing certificate will be required to be presented to a club steward before any Dog (including non-competing dogs) enters the grounds. The certificate must confirm that the dog(s) have been dosed not less than 48 hours prior to the trial date and not longer than 35 days prior to trial date. Copies of current certificates (within 35 days of the trial) may be forwarded/mailed to the Club Secretary.
10. Eight or more dogs to be entered for third place trophy to be awarded.
11. Five or more dogs to be entered for second place trophy to be awarded.
12. Failure to abide by the above rules will lead to the dog/dogs being disqualified from events entered
13. Monies MUST accompany entry
14. Any obstacles on the course will be clearly identified.
