5. Trial to be run under the Walkup Rules & Regulations of the NZGTA. A copy will be available.
6. Competitors must be a current financial member of an NZGTA affiliated club.
7. All competitors / visitors and dogs attend at their own risk. Obstacles identified where possible.
8. A dog toileting / exercise area will be designated.
9. No late entries will be accepted.
