Sunday: ABHR and RET lands. Minor trials

Emergency Judges: Club reserves the right to appoint emergency judges for any event.

Conditions of Entry:

1. All dogs entered in Championship events must be purebred and registered on the NZKC No. 1 or 3 Register.
2. Schedule approved by and trial held under the Rules and Regulations of the NZGTA. These rules will be displayed at the trial. The NZGTA has granted an exemption so handlers do not need to handle a firearm or fire a shot.
3. All Competitors must be current financial members of an affiliated club.
4. All competitors must produce a current 35 day dosing certificate as required by the landowners.
5. All competitors and dogs compete at their own risk.
6. Game in good condition will be used for each dog in each section of the Championship.
7. A monetary penalty of \$10.00 (10 dollars) will be imposed for breach of Regulation Gen. 7. (c).
8. The Committee reserves the right to make any alterations to this schedule/trial to meet any emergency.
9. No late entries will be accepted.
10. Engraving to be the responsibility and cost of the winners
11. Walk up retrieve. this event will be for a maximum of 12 dogs, if entries exceed 12 dogs, the club will hold a ballot
