- 1) All championship dogs must be purebred & registered NZKC No. 1 or No. 3 Register
- 2) All dogs entered at the owners risk.
- 3) Engraving to be the responsibility & cost of the winner.
- 4) The committee reserves the right to alter judges & grounds if required.
- 5) Full pedigree name and registration number must be supplied at time of entry.
- 6) Eight or more dogs to be entered for third place trophy to be awarded, five or more dogs to be entered for second place to be awarded.
- 7) Retriever Walk Up this event will be a maximum of 12 dogs. If entries exceed 12 dogs, the club will hold a ballot at the Tai Tapu Pub on the 2<sup>nd</sup> Feb 2024 at 6:30pm.
