1. For all championship events, all dogs must be purebred & registered on the NZKC No. 1 or No. 3 Register.
2. Registration numbers must be supplied with championship entries.
3. Trials to be run under the Rules & Regulations of the NZGTA. These rules will be on display.
4. All competitors must be a current financial member of an affiliated club.
5. Feather and fur in good condition will be used for each dog. All obstacles will be clearly defined.
6. All competitors / visitors and dogs compete and attend at their own risk.
7. The committee reserves the right to make any alterations to this schedule.

If entries exceed maximum numbers allowed, those who have not placed in an open walk up will be balloted out, those who miss out will be contacted ASAP.

This event will be a maximum of 12 dogs with 2 Judges, if entries exceed 12 dogs the Club will hold a ballot. The ballot, if required, will be held at 596 Te Kopia Rd on 28th July at 7pm in accordance with NZGTA rules and regulations.
