

CONDITIONS OF ENTRY

- All dogs entered in championship events must be purebred and registered on the NZKC No. 1 or 3 Register.
- 2. Schedule approved by and trial held under the Rules and Regulations of the NZGTA. These rules will be displayed at the trial.
- 3. All competitors must be current financial members of an affiliated club.
- 4. All competitors must produce a current 35 day dosing certificate as required by the landowner.
- 5. All competitors and dogs compete at their own risk.
- 6. All obstacles within the courses will be clearly defined.
- 7. Game in good condition will be used for each dog in each section of the Championship.
- 8. A monetary penalty of \$5.00 will be imposed for breach of Regulation Gen. 7. (c).
- 9. The committee reserves the right to make any alterations to this schedule to meet any emergency.
- 10. In puppy events, dummies may be used.
