  4. All competitors must be a current financial member of an affiliated club.
  5. Feather in good condition will be used for each dog. All obstacles will be clearly defined.
  6. All competitors / visitors and dogs compete and attend at their own risk.

  8. There must be 5 or more entries for a 2<sup>nd</sup> prize to be awarded and a minimum of 8 entries for a 3<sup>rd</sup> prize to be awarded.
