Trials Captain's Briefing will be held 10 minutes prior to the commencement of each trial, at the trials HQ.

Conditions of Entry:

- 1) All championship dogs must be purebred & registered NZKC No. 1 or No. 3 Register
- 2) Full pedigree name and registration number must be supplied at time of entry.
- 3) All competitors and dogs compete at their own risk.
- 4) Engraving to be the responsibility & cost of the winner.
- 5) The committee reserves the right to alter judges & grounds if required.
- 6) **A current dosing certificate must be provided prior to entry to the grounds.**
- 7) Eight or more dogs to be entered for third place trophy to be awarded, five or more dogs to be entered for second place to be awarded.
- 8) Schedule approved by, and the trials held under the Rules and Regulations of the NZGTA, a copy of which will be available at the Secretary's office.
- 9) Retriever Walk Up - this event will be a maximum of 12 dogs. If entries exceed 12 dogs, the club will hold a ballot at the Tai Tapu Pub on the 16th Feb 2024 at 6:30pm.
