POSTAL ENTRIES FOR CHAMPIONSHIP TRIALS CLOSE WITH THE TRIALS SECRETARY ON 24th August 2024. A draw will be forwarded to competitors, but brace positions will be drawn on the day. No late entries will be accepted.

All dogs entered in Championship events must be purebred and registered on the NZKC No. 1 register. Trials will be run under the NZGTA Rules & Regulations. Rules will be available at trial. All competitors must be members of an affiliated club. **A FIREARMS LICENSE MUST BE SIGHTED FOR ALL CHAMPIONSHIP COMPETITORS. In novice trials, a novice handler unable to comply will not be permitted to handle a firearm and a steward will be appointed to shoot on their behalf.** Game in good condition will be used for each dog in each Championship. There will be a penalty of \$10.00 charged for contravening NZGTA Regulation Gen. 7 (c). The committee reserves the right to make any alteration to this schedule to meet any emergency. All competitors compete at their own risk. No training permitted on the grounds two weeks prior to these Championships.
