## CONDITIONS OF ENTRY

1. All dogs entered in championship events must be purebred and registered on the NZKC No. 1 or 3 Register.
2. Schedule approved by and trial held under the Rules and Regulations of the NZGTA. These rules will be displayed at the trial.
3. All competitors must be current financial members of an affiliated club.
4. All competitors must produce a current 35 day dosing certificate as required by the land owner.
5. All competitors and dogs compete at their own risk.
6. All obstacles within the courses will be clearly defined.
7. Game in good condition will be used for each dog in each section of the Championship.
8. A monetary penalty of \$5.00 will be imposed for breach of Regulation Gen. 7. (c).
9. The committee reserves the right to make any alterations to this schedule to meet any emergency.
10. Seven or more dogs to be entered for third place trophy to be awarded.
11. Five or more dogs to be entered for second place trophy to be awarded.
12. In puppy events, dummies may be used.
13. In the All Breeds and Spaniel events, any competitors that do not complete the water section are asked to run the land section only after all competitors that completed the water section have competed on the land section.
