**DOSING CERTIFICATES MUST BE CARRIED and will be checked on the day (See Note 9 below).**

### **POSTAL ENTRIES CLOSE 6.00PM on 21 JULY 2021**

- Please post entry form or, scan a copy of the completed entry form and send it by email, plus deposit monies into club bank account – details below. Send a notice to the Field Trial secretary of your action please.
- Draw for positions of running will be made as soon as possible after the close of entries.
- No catering will be available so bring your own food and drink plus water for dogs.
- Handlers are required to comply with NZ Firearms laws.
- Handlers that do not have a current firearms license will be required to have a licensed firearms person supervise them during the time they are running their dog.

## CONDITIONS OF ENTRY

- 1: All dogs entered in the Championship trials must be pure bred and registered with DOGS NZ on the No 1 or No 3 Register
- 2: This schedule has been approved by, and the trials will be run under the NZGTA Rules and Regulations. Rules will be displayed at the championship trials.
- 3: All competitors must be members of an NZGTA affiliated club.
- 4: *NO LATE ENTRIES WILL BE ACCEPTED.*
- 5: Game in good condition will be used for each dog in each section of the Championship trial.
- 6: There will be a penalty of \$5.00 for any dog that is in breach of Regulation Gen.7. (c).
- 7: All competitors and dogs attend at their own risk.
- 8: The Brittany Club committee reserves the right to make any alterations to this schedule to meet any emergency.
- 9: **A current Dog Dosing certificate will be required to be presented to a club steward before any dog (including non competing dogs) enter the grounds. The certificate must confirm that the dog(s) have been dosed not less than 48 hours prior to the trial date and no longer than 35 days prior to the trial date. Copies of current certificates (within 35 days of the trial) may be forwarded /emailed to the Club Secretary prior to the trial day.**
- 10: Failure to abide by the above rules will lead to the dog/dogs being disqualified from events entered.
- 11: Monies paid **MUST** accompany each entry.
- 12: Upland game birds such as pheasants or quail may be used for the retrieve.

**TRIAL ONE: Homer, Dead Bird, Homer.**

**JUDGE: Don Mackay**

Range, find and point/set one homer. Shot to be fired by handler over dog on release of the homer to test steadiness to game and shot. Range, find and retrieve one dead bird concealed in cover. Dog to then range, find and point/set another homer. Shot to be fired by handler over the dog on release of the homer to test steadiness to game and shot.

**ONE challenge point to the winner. ENTRY FEE: \$15.00 + \$5.00 levy, TOTAL \$20.00**

**TROPHIES: 1<sup>st</sup> Trophy and rosette, 2<sup>nd</sup> & 3<sup>rd</sup> Merit Certificates.**

**TRIAL TWO: Homer, Homer, Dead Bird.**

**JUDGE: Neil Stewart**

Range, Find and point/set one homer. Shot to be fired by handler over dog on release of homer to test for steadiness to game and shot. Range, find and point/set another homer. Shot to be fired by handler over dog on release of homer to test for steadiness to game and shot. Range, find and retrieve one dead bird concealed in cover.
