- 1) All championship dogs must be purebred & registered NZKC No.1
- 2) Minor trials are open to all dogs (NZKC No.1 Register, or No. 2 register, or unregistered)
- 3) All dogs entered at the owners risk.
- 4) Engraving to be the responsibility & cost of the winner.
- 5) The committee reserves the right to alter judges & grounds if required.
- 6) NZGTA Rules & Regulations will be available at the Secretary's office
- 6) Full pedigree name and registration number must be supplied at time of entry.
- 7) Eight or more dogs to be entered for third place trophy to be awarded, five or more dogs to be entered for second place to be awarded.
- 8) Retriever Walk Up – this event will be a maximum of 12 dogs. If entires exceed 12 dogs, the club will hold a ballot at the Tai Tapu Pub on the 17<sup>th</sup> Sept at 6pm
