CENTRAL OTAGO RETRIEVER TEAMS TROPHY

To be competed for by teams of three dogs from the same club competing in the 2 Retriever Trials. Entries to the trial secretary by 9:00am Saturday.

Entry: \$5.00 per team.

MACDONALD FAMILY TROPHY:

To be awarded to the local club dog winning the most points in minor competitions.

DOUG GREEN MEMORIAL TROPHY:

To be awarded to the non-champion dog gaining most points in the Retriever Championship.

RULES & REGULATIONS:

- 1) All dogs in open events must be purebred & registered on the NZKC No. 1 or No 3 register.
- 2) Schedule approved & trials run under rules & regulations of the NZGTA
- 3) All competitors must be financial members of an affiliated club & membership cards must be produced on request.
- 4) No late entries will be accepted.
- 5) Competitors who fail to be on the mark when required are liable to disqualification.
- 6) Birds in good condition will be used for each section of the Championship events.
- 7) Eight or more dogs to be entered for third place to be awarded. Five dogs must be entered for second place to be awarded.
- 8) All dogs entered at the owners' risk.
- 9) All dogs to be tied where designated.
- 10) All dogs to be on a leash except in the exercise area or when competing.
- 11) A current dosing certificate for all dogs present on the day to be produced upon request.
- 12) Penalty for breach of Reg. Gen. 7c is \$5.00.
- 13) Engraving to be the responsibility & cost of the winner.
- 14) The committee reserves the right to alter start times, judges & grounds if required.

There will be refreshments available to purchase on both days.
