## **Conditions of Entry:**

1. All championship dogs must be purebred & registered NZKC No. 1 or No. 3 Register
2. All dogs entered at the owners risk.
3. Engraving to be the responsibility & cost of the winner.
4. The committee reserves the right to alter judges & grounds if required.
5. Full pedigree name and registration number must be supplied at time of entry.
6. Eight or more dogs to be entered for third place trophy to be awarded, five or more dogs to be entered for second place to be awarded.
7. Retriever Walk Up - this event will be a maximum of 12 dogs. If entries exceed 12 dogs, the club will hold a ballot at the Tai Tapu Pub on the March 22<sup>nd</sup> 2024 at 6:30pm.
