## CONDITIONS OF ENTRY

1. All dogs must be purebred and registered on the NZKC number 1 register.
2. Trials will be run under NZGTA Rules & Regulations, a copy of which will be displayed at the Secretary's table.
3. All competitors must be a member of an affiliated club.
4. Birds in good condition will be used for all events.
5. In retrieving classes, all obstacles within the prescribed course will be clearly defined.
6. A monetary penalty (\$20.00) will be imposed for breach of Regulations General 7 (c).
7. All competitors and their dogs compete at their own risk.
8. Dogs Registration No. MUST be supplied at time of entry.
9. Firearms licenses will be sighted by the Trial Captain or Club Secretary before the trial begins.
10. For those without a firearms license, a licensed gun steward will accompany you as per the New Zealand firearms laws.
11. The committee reserves the right to amend this schedule to meet any emergency.
12. Trophy engraving is winners' responsibility.
